ORDINANCE NO. 5972

AN ORDINANCE WITHDRAWING TERRITORY IDENTIFIED ON LINN COUNTY ASSESSOR'S MAP NO. 11S-03W-04AB AS TAX LOT 300 FROM THE ALBANY RURAL FIRE PROTECTION DISTRICT.

WHEREAS, on November 9, 2021, the Albany Community Development Department received an application for annexation with concurrent zoning map amendment for a 0.94-acre parcel addressed as 420 Clover Ridge Road NE (Planning Files AN-01-21 and ZC-03-21); and

WHEREAS, annexation of the subject property results in withdrawal of the territory from the Albany Rural Fire Protection District (ARFPD); and

WHEREAS, on March 14, 2022, the Albany Planning Commission held a public hearing, considered public testimony, deliberated on the proposed annexation with zoning map amendment, and recommended approval of the proposal based on evidence presented in the staff report and during the public hearing; and

WHEREAS, on April 13, 2022, the Albany City Council held a public hearing during which time interested persons were given an opportunity to be heard on this matter; and

WHEREAS, the City Council, following said public hearing, determined that the withdrawal of territory from the ARFPD is in the best interests of the citizens of Albany.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: The territory shown on the map in Exhibit A and described in Exhibit B of this ordinance is hereby proclaimed to be withdrawn from the Albany Rural Fire Protection District.


